Your account holder's signature on this Contract is an assurance that you are of legal age and are authorized to enter into this contract and be bound by its clauses.

No modifications to this Agreement of any kind are allowed – a new Contract must be undertaken and consummated.

This Show Contract will cover an individual Event, or Multiple-Events, and such will be indicated on the attached **Schedule A – Event Selection(s)**.

Such Events will indicate the Event Name, Date of Event, Hours of Event, Location, and space price options. You will indicate your choices and options on this schedule. You need to clearly and accurately make your selections and complete your calculations. You must also sign this Schedule.

PAYMENT

Payment is due on or before the date this Show Contract is submitted, or within 24-hours of submission if provided online. If you are choosing to make payment by Credit Card, Debit Card or by Check, this information or Check must be indicated on **Schedule B – Event Payment(s)**.

For your protection and security, you may elect to make your Order and Payment online using EventBrite, subject to the provisions above. You may search for the Event, or you may access the main Spiritual Living Expos website for a direct link. Spiritual Living Expos bears no responsibility for EventBrite or third-party processors.

PROMOTER

The Promoter for this/these Show(s) for which you are contracting is SPIRITUAL LIVING EXPOS INC, a Wyoming corporation. This is the party and jurisdiction pertaining to this transaction. Spiritual Living Expos Inc is a provider of Spiritual Events throughout America. It provides its service and takes payment online through this jurisdiction. Spiritual Living Expos works with local providers, coordinators, representatives and agents in the local of the event to bring its themed and advertised events and services.

The applicant agrees to hold harmless Spiritual Living Expos Inc, and any of its agents and representatives, and any local providers, coordinators, representatives and agents in the local of the event, from any and all claims, demands, suits, damages, liability, loss, expenses and attorney fees which may arise out of any action of failure to act. These include, but are not limited to, claims of damages or loss of time, investment, property, injury, harm or death to applicants and their representatives, Spiritual Living Expos Inc and its representatives, local promotional representatives, and venue

visitors. Spiritual Living Expos Inc and its collective representatives as indicated above shall not be held liable for damages from fire, water, earthquakes, hurricanes and tropical storms, and other Acts of God.

FIRE AND SAFETY LAWS

Any and all Federal, State, County or City laws will be observed. This may include flameproof wiring and fire-retardant materials, construction and decorations. Wiring must comply with Fire Department and Underwriter's rules. Smoking in exhibits, including "Saging", and such may also be prohibited by the facility, or in specific areas.

Any massage services, devices apparatus and tables and chairs are only permitted by being a City or Country licensed massage therapist, whichever applies. Individual(s) performing these services must be appropriately licensed during the event. Any and all fines imposed by the authorities will be paid solely by the Exhibiting company, entity or individual(s).

TAXES AND FEES

Any government or facility dictated taxes, fees, fines, levies or parking charges are the sole responsibility of the Account exhibitor.

RESCHEDULING

In the event the Show contracted for is pre-empted by the Hotel or hosting venue, or for an Act of God or any other cause, then Spiritual Living Expos Inc will not make a Refund – it will provide a access to an appropriate substitute venue with 1 year from the date of the affected Event.

CANCELLATION

There are no refunds for Cancellation(s) of any kind, for any reason. You have thirty (30) calendar days before an event to reschedule it to a comparable substitute Event within 365 days of the Event date affected.

Any cancellation or refund related situation not specifically covered by this Agreement shall still be subject to a 50% loss and restocking fee.

SECURITY

Spiritual Living Expos Inc will rely solely on the security provisions and the resources of the facility contracted with to physically house the Event.

Each Show and/or Account exhibitor shall purchase his or her own insurance, as they assume sole liability for losses and damages arising out of the Show and/or venue's activities.

AMENDMENTS

Spiritual Living Expos Inc has the sole discretion on how to act or rule on areas of concern, or unanswered questions or areas.

EXHIBITOR RESPONSIBILITY OF REPRESENTATIVES, AGENTS, SALES PERSONS AND PRACTITIONERS

Each and every exhibitor, without exception, will designate at least one person to be his or her representative in connection with the installation, the operation and the removal of their exhibit and materials.

Further, such representatives shall have the necessary authorization to enter into such service contracts as may be necessary to accomplish the above indicated responsibilities.

Such persons shall also be responsible for observing the opening and closing hours, and the setup and shutdown hours and possibilities. He or she is responsible for Exhibit Placement agreements that are a part of this Agreement.

Similarly, said representatives shall secure Passes or Badges if subscribed for the Event, and return such credentials if required by the Event.

Said representatives shall ensure that closing down an exhibit does not interfere with the operation of the Event, and other exhibitors and attendees, or the agents and representatives of Spiritual Living Expos Inc. This would particularly include noise, visual disturbances and blocking of the isles and walkways.

NO VENDOR IS ALLOWED TO INTERFERE with the harmonious enjoyment of their exhibit, space and peace of mind of any other exhibitor, or the Agent(s) of Spiritual Living Expos Inc. at the Venue. The responsible part of each Exhibit must do their part to ensure this Right.

NO VERBAL MARKETING outside of the Vendor's / Exhibitor's booth is allowed. This includes the walkways, hallways, rest rooms and Event service and support areas.

No shipments to, or receipt by, the Venue, facility or Spiritual Living Expos Inc. is allowable.

EXHIBIT PLACEMENT

All tables, chairs, banners, displays, materials and products associated with the Account/Vendor/Show Exhibitor shall remain WITHIN THE VENDOR SPACE and all times. Specifically, such items may NOT be displayed or stored in the isles and walking spaces, or between them and an adjoin space. The doors, offices and facilities of the Venue or facility may not be blocked.

Exhibitors may not affix, nail or attach any displays or materials on the Venue or facility's walls, doors, windows and property.

Exhibitors display materials, tools of trade and products will not cause excess or unreasonable noise or disturbance to other exhibitors, patrons or the representatives and agents of Spiritual Living Expos, Inc. Upon official notice you will have fifteen (15) minutes only to correct the disturbance or you will waive your attendance and be rejected from the show without refund or substitution.

The same clause above refers to any display that is offensive at the discretion of the representatives or agents of Spiritual Living Expos Inc.

SUB-LEASING

There shall be no sub-leasing, subletting, assignment or reassignment of assigned and/or allocated Space.

ENTIRE AGREEMENT

This printed means of communication contains the entire agreement between the parties relating to the subject matter hereof. This Agreement is complete, absolute and final.
